**CIRCULAR**

In accordance to the para 8.1 of the Operational Guidelines of Ministry of Youth Affairs and Sports Government of India, F.No.54-1/MYAS/MDSD/2017, Dt. 26.12.2017, removal (including temporary discontinuous) of the players from the scheme is done after the performance assessment of Khelo India Athletes (KIAs) by the Talent Identification and Development Committee (TIDC)
