## 1. Eligibility Criteria:

### A. Junior Consultant (IT):

#### a) **Essential Qualification:**

i. Regular B.E./B.Tech./M.Tech. in IT/Computer Science or MCA.

ii. Minimum 08 Years of experience in Technical Architecture; Experience with Database Management (Windows/Linux server), complete knowledge of SDLC, Testing/Debugging, Web designing/development and implementation.

#### b) **Desirable:**

i. Programming languages .Net, PHP, CSS, REST API, AJAX, JSON, jQuery, Javascripting and application development/designing environments.

ii. Cloud database structuring and management (including VM installation and hosting of applications on cloud).

iii. Experience in Vulnerability Assessment and Penetration Testing (VAPT) / Security Audits in hosting web applications, database infrastructure.

iv. Expertise in MVC, .NET Framework, ASP.NET Web Forms, C#, .NET, ADO.NET, XML, Entity Framework, LINQ, SQL server 2000/2005/2008 R2, Mobile Applications (Hybrid, Android, J2ME).

c) **Remuneration:** Rs.75,000/- Rs. 1 Lakhs per month.

#### a) **Essential Qualification:**

**2. Tenure:**

The contractual engagement will be for a period of 01 (One) year, extendable for 03 (Three) years or coterminous with the scheme whichever is earlier. The performance of the selected candidates shall be continuously reviewed and extension will be considered on the basis of periodic review / requirement. The increment may be considered after one year based on the performance. The contract may be terminated by giving one-month notice period.

**3. General Terms and Conditions:**

**A. Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the SAI will issue TDS /Service Tax Certificates, as applicable.

**B. Other Allowances:** No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance/Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.

**C. Leave:** Selected candidates will be entitled for 30 days leave in a calendar year on pro-rata basis. Therefore, candidates shall not draw any remuneration in case of his/her absence beyond 30 days in a year. Also unavailed leave in a calendar year will lapse and will not be carried forward to the next calendar year.

**D. Confidentiality:**

- a) Selected persons will not be allowed to publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymously in the name of any other person, if such book, article, broadcast, uses any information that he/she may gather as part of this assignment.
