The said queries have been received through e-mail from the prospective bidders and the proposed clarifications to the queries are tabulated as hereunder:

1	Bidder shall promptly initiate a search for a replacement to ensure that the role of any member of the Key resource is not vacant for any longer than 07 days, subject to reasonable extensions, limited to a maximum of 15 days on special request by Bidder to SAI	While we as bidders would try our best to replace any resource leaving the project for whatsoever reason, 7 days is a difficult as any resource would have to serve his/her notice period in their current organisation. Request to extend the replacement / joining timeline to 3-4 weeks on the minimum	No change in RFP.
2	The bidder must ensure at least 4 weeks overlap period for knowledge transfer in such replacements.	Again, while the bidders would try their level best, but our experience suggest that any resource severing contract with employer may not give such time period notice and often leave without notice.
