NOTICE

In accordance to the Para 8.1 (2) of the Operational Guidelines of Ministry of Youth Affairs and Sports, Government of India, F.No. 54-1/MYAS/MDSD/2017 Dt. 26.12.2017, removal (including temporary discontinuation) of the player from the scheme is to be done after the performance assessment of Khelo India Athletes (KIAs)/ NCOE athletes by the Talent Identification and Development Committee (TIDC).

- 2. In this regard, all concerned are hereby informed through this notice regarding the removal of following athletes of sports discipline of Judo from Khelo India Scheme/NCOE Scheme on the basis of recommendations of Talent Identification & Development Committee (Judo) are as follows:
 - a) These athletes henceforth, shall not be treated as part of Khelo India Scheme/NCOE Scheme, and all the facilities and other ancillary expenses including services extended under Khelo India Scheme/NCOE Scheme shall be withdrawn w.e.f. the date of withdrawal from Khelo India Scheme/NCOE Scheme.
